A SCHEDULE OF FEES AND CHARGES FOR THE BOROUGH OF PALMERTON

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Palmerton, County of Carbon, Commonwealth of Pennsylvania, that the schedule of fees and charges for the Borough of Palmerton is as follows:

Sheds/Decks/Above-Ground Pools/Minor Interior or Exterior Renovations, Fences, Walls	\$30/first 100 sq.ft., plus \$5 for each additional 100 sq.ft. or portion thereof

Dumpster Permit	\$50 first two weeks, \$25/week in advance for each following consecutive seven days
Finger Printing	\$10.00 for non-residents
Mechanical Device Tax	\$15/year mechanical device \$11/quarter electrical device \$18.50/quarter electronic device
Moving Permit	\$5.00
Occupancy Permit for Business	\$30.00
Park Bandstand	\$50 for non-residents If event is cancelled 30 days prior, ½ refunded. If cancelled less than 30 days, payment is forfeited.
Parking Ticket	\$30.00/\$70.00 after 72 hrs.
Handicap Parking Violation	\$50.00/\$100 after 72 hrs.
Peddling and Soliciting	\$100/month, \$500/year, or \$20/day up to 3 days
Plumbing License	\$30/year
Plumbing Permit	\$50 for rough and final inspections \$40 each additional inspection
Restaurant Inspection	\$50 per inspection (includes initial and one return for compliance) \$30 for additional inspections for occupancy or compliance
Returned Check (by bank)	\$20 plus bank fee



Sewer Connection	See Chapter 105-17
Sewer Enforcement and Sewage Permits	See annually approved rate schedule
Sewer Rentals or Charges	See Chapter 105-2
Sewer Tap-In Fee	\$980 per EDU
Sidewalk and Curb	No Fee
Sign Permit	\$.50 per square foot (minimum fee \$20, maximum fee \$40)
Solid Waste Service	\$119.00/quarter
Stormwater Management Plan Permit	\$200 permit application, plus \$1,000 review cost deposit. Costs are set by Borough Engineering fee schedules adopted annually for general Borough work. These fees shall be adopted annually with adoption of the Borough's schedule for salaries. When the deposit has been exhausted, the Borough will invoice and the applicant shall be responsible for any/all additional costs.
